## TERMS AND CONDITIONS FOR SPECIAL PLATES

1. The number plates always remain the property of Transport
2. The number plates shall not be attached to a TAXI, OMNIBUS or any other vehicle which requires specific identifying number plates allocated by Transport.
3. If the holder of the RIGHT to DISPLAY AND TRADE CERTIFICATE does not nominate a Western Australian vehicle on which to display the plates, the plates must be stored by Transport.

### THE RIGHT TO DISPLAY AND TRADE

An applicant for a Special plate will be issued with a Certificate of Right to Display and Trade. The holder of the Right to Display and Trade Certificate can offer that right for sale. The sale can take place at any price to any individual or corporation by transferring the right.

### TRANSFER OF RIGHT TO DISPLAY AND TRADE

The holder of a Right to Display and Trade Certificate may transfer that right. With each transfer, Transport must be notified of the transaction on a completed *Transfer of Right to Display and Trade Plate*, FORM 6. The seller of the right must within 14 days of the plate transfer present to Transport the following:

- the duplicate of the *Transfer of Right to Display and Trade Plate*, FORM 6.
- the number plates if not already held by Transport
- the Right to Display and Trade Certificate

The purchaser of the Right to Display and Trade must present the original *Transfer of Right to Display and Trade Plate*, FORM 6 to State Revenue 200 St Georges Tce Perth. A stamp duty of \$1.95 per \$100.00 of the purchase price of the plates will be payable. (Fees correct at the time of printing – July 2000)

The purchaser must then present to Transport the following:

- the original of the Plate transfer form showing receipt of the appropriate stamp duty paid to State Revenue
- the existing number plates on the vehicle to which the Special Plates are to be displayed.

Transport will issue a new Certificate of Right to Display and Trade to the new owner.

### STORAGE OF PLATES

Plates not attached to a Western Australian licensed vehicle will be stored by a Transport Licensing Centre or Authorised Agent and a storage fee for each year or part year will be charged to the owner of the Right to Display and Trade.
